We will explore various aspects of childhood history, including topics such as: child labour; immigrant children; First Nations children; adoption; the advent of child welfare; education; advice literature; and other aspects of child and teenage culture (books, movies, television, music, and trends). To understand the variety of childhood experiences in Canada, we will consider such factors as race, class, gender, and region. This course is restricted to upper year students or permission of the department. (lec/sem 3) 3 cr

Woodman questioned the tenure track positions and CLTAs, specifically, concerns regarding social work accreditation.

Myers stated that it is a complicated situation that requires reflection and negotiation. He stated that there is a full time instructor currently teaching at the Timmins extension who is not able to apply for tenure due to a contractual agreement with Northern College. He added that all options must be explored before a decision is made.

Bloomfield expressed concerns regarding APPCOM's recommendations as Psychology will have two faculty on sabbatical and one on a leave of absence.

Myers commented that we will do our best to ensure programs have coverage.

R. Cameron commented that the department (Social Work) met quite often and expressed the need for a tenure track positon for Timmins.

Myers stated he hoped for the same as the program grows and is open for more discussion.

Kadiyala expressed concern regarding the number of faculty and number of courses to be taught in Economics.

Myers commented that the FTEs indicate significant growth in ECON and that he is familiar with the challenges the department is facing. He added that there are a few programs that are in need of resources.

Graydon questioned why the Student Union was being asked to contribute to the funding of the GLC and why so late during the renovations.

Myers answered that it is normal for universities to ask their student unions for funding, other universities have been asked to contribute much more.
