Moved (Hermida/Jimenez-Estrada): that Senate approve Dr. Trevor Tchir to serve as Senate representative from the Department of Law and Politics replacing Dr. Neil Cruickshank for the rest of the 2017 – 18 Senate year.

# 18.01.05 DECISION ITEMS (for action) 18.01.05.01 Scholarship Committee – Entrance/In-course Scholarships 2017-18

Moved (Cameron/Matthews): that Senate approve the Algoma University Entrance and Incourses scholarships lists for the 2017-2018 academic year as submitted.

Moved (Schamp/Imre): that Senate approve the appointment of Dr. Daniel Doucet as Adjunct Professor (Department of Biology) for a three-year term, effective January 2018.

### Rationale:

Dr Doucet is a research scientist working at the Canadian Forest Service in Sault Ste Marie Ontario. His research interests involve various applications of insect genomics, molecular biology and cell biology for pest management, such as survey and detection and insect chemical control. His current work is focused on the characterization of odorant receptors from invasive beetle species (e.g. the Brown Spruce Longhorned Beetle and the Emerald Ash Borer), the molecular underpinnings of host plant interactions in wood boring beetles, and synthetic hormone agonists for insect control.

Dr. Doucet's expertise is complementary to the department's faculty. His appointment could benefit undergraduate students and postdoctoral fellows interested in one or multiple aspects of insect biology, spanning biochemistry, cell biology and physiology, with an emphasis on forest invasives. Dr. Doucet has active collaborations with academics in India (D. Ampasala, Pondicherry University), China (Z. Zhou, Henan S&T University) and Belgium (G. Smagghe, University of Ghent), which could expand the research opportunities of prospective Algoma University students and fellows. The facilities under his supervision offer excellent training opportunities in cell biology (one of the few labs in the world dedicated to insect cell culture), molecular biology and microscopy.

Dr. Doucet has prior involvement with Algoma University, having hosted a Brazil exchange student, taught two invited lectures and having assisted in the administration of the last two years of a Tier I CRC grant held by Professor Jenny Cory. His experience and knowledge should be of service to the department, and should help strengthening the existing partnership that exists with GLFC.

### Rationale:

Dr. Jude Ortiz has taught for a number of years in the CESD Program and is also the principal Research Coordinator at NORDIK Institute, an academic institute affiliated with the CESD Program at Algoma University. This appointment will facilitate continued teaching in the program, research and collaborative work (including participation in collaborative research and applications to SSHRC and other funding agencies).

Moved (Matthews/Marasco): that Senate approve the appointment of Professor Sean Meades as Adjunct Professor (Department of Community, Economic and Social Development) for a three-year term, effective January 2018.

# Rationale:

Prof Sean Meades has taught for a number of years in the CESD program and considered a strong asset to the program and department. He has taught upper year theory core and special topics courses in key content areas. Prof Meades is acting Director of NORDIK Institute, an academic institute affiliated with the CESD Program at Algoma University. This appointment will facilitate

continued teaching in the program, research and collaborative work (including participation in collaborative research and applications to SSHRC and other funding agencies).

#### **BRAMPTON AND TIMMINS EXTENSIONS**

The committee agreed that potential positions proposed for the two extension sites would be considered through a separate process as part of a larger strategic proposal that would potentially include a package of supports for each extension.

Members of Academic Planning and Priorities spoke in support of the motion, adding that a significant amount of time was spent in finalizing the hiring recommendations given the enrollment challenges. There was a discussion on how the final ranked positions were determined – the committee's mandate was to address immediate and urgent needs.

Regarding the unranked positions, the committee listed them in alpha order while identifying a need in each department, however, in no order of priority. Pending budget allocations, the ranking of the positions may be re-visited.

With respect to the extension sites, more administrative input is required to determine a business case model/structure and enrolment strategies.
