Moved (Newbigging/Boyle): that Senate approve the following new course as submitted by the Department of History and Philosophy:

HIST 2896 Colony to Communist Nation: Cuba – Case Study in Colonialism

The history of Cuba provides us with a unique perspective on one of the most important forces in modern history, colonialism. By using the Cuban experience as a paradigm students will trace the history of the colonial experience in the new world from first contact until the present day. Cuba's example serves to bring the salient themes of colonialism – contact between Europeans and Indigenous peoples, missionary endeavour, resource exploitation, slavery, war, independence movements, and revolution - into sharp focus. (lec 3) 3 cr

Shaw asked whether the course will be taught in Cuba.

Newbigging answered that one week will be in St Thomas and two weeks will be in Cuba.

Woodman asked about prerequisites.

Newbigging confirmed that there are no prerequisites for the course.

Shaw asked about students who cannot travel to Cuba.

Newbigging said the course is optional.

Gruner explained the motion.

Motion carried.

Curriculum Committee

Motion to Establish a Sub-Committee of CURCOM (Indigenous Learning Committee)

In accord with the University's special mission to cultivate cross-cultural learning between aboriginal communities and other communities and the University's institutional commitment to engage in a special partnership with Shingwauk Kinoomaage Gamig, the Curriculum Committee of Senate recommends the following mechanism for consultation on indigenous course content in the curriculum:

- 1. All new courses/programs will be assessed for indigenous content
- 2. If the indigenous course content is a core component of the course (e.g., indigenous language, culture, history that is, the course/program could not be taught otherwise then a two-fold consultation is required:

a. Initial (i.e., during course/program development) consultation with the Indigenous Learning Committee (of Senate), whose mandate is to examine current programmes with regard to their Indigenous content, propose changes to improve those programmes, and provide input for new academic initiatives. The Committee serves as a vehicle for consulting with Indigenous communities and organizations about existing programmes and new/proposed ones. While in its earlier incarnation, the Committee reported to APPCOM, this Committee going forward would report to CURCOM. Important here is that AU faculty developing courses with core indigenous content receive counsel during the course/program development, not afterward.

- b. Consultation with academic members of Shingwauk Kinoomaage Gamig, who would provide advice/counsel on course content
- 3. Following confirmation of the two-fold consultation and the incorporation of any recommended content that the instructor deems appropriate, the Curriculum Committee would receive and consider the course/program. CURCOM consideration will employ the same standards and guidelines for approvals as with other courses/programs under its review

Recognizing the mutual autonomy of both the Indigenous communities and the University, the mechanism outlined above recommends a collaborative process of curriculum development that meets our special mission to cultivate cross-cultural learning amongst our communities.

Moved (Perlini/Benton-Benai): that Senate approve the establishment of a sub-committee of the Curriculum Committee (Indigenous Learning Committee) as follows:

Composition:

- One faculty divisional representative from each of the three divisions;
- One representative from the Children of Shingwauk Alumni Association
- One representative from Shingwauk Kinoomaage Gamig (SKG)
- One representative from the Anishinaabe Peoples Council (APC)
- One representative from the Shingwauk Anishinaabe Students Assocation (SASA)
- One representative from the Anishinaabe Student Success Division

Perlini explained the purpose of the committee. He noted that questions were raised about two previous course proposals that had not received adequate consultation before coming to senate. The committee will give faculty members access to guidance and advice from aboriginal representatives for new courses with significant indigenous content.

Savory-Gordon noted she was once a chair for the previous incarnation of the committee. Previously, the committee dealt with more than indigenous content in courses and included program development. She suggested that the committee should be involved with both APPCOM and CURCOM.

Verrelli asked how the course content will be identified.

Perlini said that faculty members are responsible to declare, on the new course form, if the course includes indigenous content.

Schantz said that it is important to have course syllabi reviewed.

Verrelli asked how the course syllabi will be reviewed.

Schantz said he was referring to the box on the course proposal form.

DeLuca asked whether or not guidelines will be provided about kinds and amounts of aboriginal content in course.

Perlini said the committee and SKG will provide direction to faculty.

Gruner asked whether or not a representative from SKG would speak to the motion.

Benton-Benai spoke on behalf of the motion. He said we must develop materials and methodologies that represent the truth of aboriginal history and culture.

Savory-Gordon asked for an amendment to the motion: to have the committee report to both CURCOM and APPCOM.

Perlini said that only new programs will be reviewed by APPCOM.

Woodman asked why the committee has moved from APPCOM to CURCOM.

Perlini answered that new course development reviews are necessary to ensure there is adequate consultation.

Woodman noted that there needs to be much more attention paid to the original institutional mandate and aboriginal content.

Vaillancourt suggested that a process and criteria be developed to determine what Aboriginal content would be in courses taught. She added that all faculty need to be directly involved in these discussions and the decision-making process.

Perlini asked whether or not senate would like all courses with aboriginal content to be reviewed.

Dupuis recommended against doing the work of the committee before the committee was formed and had a chance to meet. He said the discussion should be focused on approving the motion for the committee.

Briggs suggested a change to the motion: the committee would report to CURCOM on course content and report to APPCOM on program content.

Schantz suggested to insert the following: "in matters of specific course-level curriculum" would be inserted in the penultimate sentence of point 2 above.

Dupuis recommended that the committee should set its own criteria for the committees to which it would report. It should be allowed to set its own terms of reference.

Savory-Gordon suggested adding: "a sub-committee of CURCOM and APPCOM" into the actual motion.

Osei said the committee must be shared between the "two boats" of the covenant.

Vernelli asked if SKG will make its own committee. She questioned the idea of allowing a committee to set up its own mandate.

Dupuis said there is some framework in the preamble for the motion. The committee would be required to bring its mandate to the senate for approval.

Perlini said the language of point 2 was taken from the terms of reference from the dormant committee.

Benton-Benai said the committee should study the covenant.

Dupuis responded that the members of the committee should make it their own responsibility.

Shaw said that she was told, when she arrived at AU, that every course must have aboriginal content.

Dupuis said that this would be difficult for some courses, such as calculus.

Dupuis suggested inserting a line into the preamble: "and in accord with the covenant" after "institutional commitment"

12.06.04.05 Curriculum Committee/Academic Planning motion (A5)

Moved (Perlini/Kadiyala): that the Algoma University Senate supports the offsite course offerings of the BBA program on the Centennial College Campus.

Rationale:

Consistent with the University's Institutional Quality Assurance Process (IQAP) that require course offerings in another location to undergo internal approvals, the Curriculum Committee of Senate considered and supports the BBA offerings on the Centennial College campus. These course offerings will permit college diploma students to complete the Algoma University BBA program. This offsite course offering supports growth opportunities that are consistent with the University's Five Year Academic Plan. The Curriculum

Committee and the Academic Planning and Priorities Committee recommends to Senate - for Senate's approval - this offsite diplomato-degree BBA program.

Shaw said that when the senate approved of St. Thomas, the block plan was brought in the back door. She asked whether or not this could happen again for this off-site program.

Schantz said the senate must be involved in this step of the quality assurance process.

Woodman asked for someone from business to speak to the motion.

Matthews said the business program will not offer block plan courses.

Hernden asked what kinds of resources AU will be required to provide.

Perlini said that there is existing infrastructure on the college campus.

Schantz said that this will be good for both Centennial and AU.

Motion carried.

12.05.05 INFORMATION ITEMS (reports of committees) 12.06.05.01 Office of the Registrar – Convocation Report (A6)

Woodman expressed disappointment at having the convocation in the Bondar pavilion. The Convocation report was included as part of the June senate package.

12.05.06 STANDING REPORTS 12.06.06.01 Board of Governors Representative Report

Dupuis noted that there has not been a meeting since the last senate meeting.

12.06.06.02 President's Report

The President submitted a written report.

12.06.06.03 Dean's Report

The Dean submitted a written report.

12.06.06.04 SKG Report

Dupuis called on Benton-Benai. He read a report into the record. Dupuis asked for a written copy to be provided to the secretary of senate.

Rickard noted that this has been a stressful period since the Founders Day incident. He said the non-commitment from AU is troubling, especially in terms of consultation. He said that there has been little faculty representation at aboriginal events.

12.06.06.05 VP Academic & Research Report

Schantz noted the recent limitations on research funding. He noted that colleges are doing a good job of attracting the attention of different levels of government. Universities are now making a campaign. A PR firm has made the advertisements. Savory-Gordon will be featured in the ad campaign. Schantz has a letter about the campaign that will be distributed electronically. Schantz played a video on the Research Matters website. Schantz said that students should be integrated in faculty research and this makes for a better institution.

12.06.07 DISCUSSION AND QUESTION PERIOD

Graydon said he was at the Founders Day talk. He said it is an elephant in the room. He said a statement of concern was made, and it was met with silence. Graydon said he is distressed by the delays in the meeting between the university and the aboriginal representatives. He said he would like to see the matter addressed.

Gruner thanked Graydon for expressing his concerns. She said this is a moment for the university to look at the issue. Gruner said that the role of the Founder's Day Committee has been under-recognized, especially in terms of opening a discussion on aboriginal issues.

Briggs asked the dean whether or not he would consult with SKG about offering short courses to St. Thomas students while they are on the AU campus.

Perlini said he will be happy to initiate the discussion.

Vernelli asked for it to be open to faculty.

Perlini noted that the previously proposed History course will not be offered. St Thomas students will take HIST 1206 on campus.

Ridout asked whether or not events are held during welcome week for AU students.

Rickard noted that Graydon's remark was met with silence.

Syrette said a request was made for a talking circle with Dr. Newbigging at the end of classes. She was told that Newbigging would be willing to meet with students at the end of May.

Rickard said agreements have not been fulfilled.

Johnston asked for someone from the administration to respond.

Schantz said the administration is concerned about this, but does not know the details of what has actually happened. He is not familiar with the meetings that have been held. Schantz noted that there are a number of areas in which the administration is continuing to develop the processes that are already in place for aboriginal people. Schantz said he was disappointed with the events. He said while the specifics of this must be addressed, we must continue to consult and plan to ensure that the needs of the aboriginal people are heard. The administration is concerned and is doing what it can to address it.

Graydon said two circles were held and arranged by students. He did not attend. He said if this issue was a priority, everyone would know, but the students have been excluded. Graydon said everyone is afraid that this will become about academic freedom.

Schantz said that if the president was present, the questions would be answered. The president has been involved and dedicated much time to the issue. He said that the lack of answers in this meeting does not indicate that the administration or the board is unconcerned.

Shaw said this is the second discussion in a senate meeting without any answers forthcoming. She suggested that the senate should make a request to the administration for some answers or some movement to address the issue actively.

Dupuis will take Shaw's request to the president.

Boyle said she is uncomfortable speaking about the issue without the president and Dr. Newbigging being present. She suggested that there may be conversations happening that senators are not aware of.

Boissoneau said this is a moment to move forward. He spoke of the convenant and AU's request for support from SKG when AU was seeking the charter for the university. He noted that SKG hears rumours coming from AU. He said that SKG will stand with its students and they should not live in fear at an institution. He said the issue is not about Dr. Newbigging or the president at this time. The issue is in the community and spoken of among the chiefs. He noted that SKG is willing to meet. He said that students are afraid their grades will suffer because they stand up to talk about this issue.

Briggs reiterated Boissoneau's point: it is an issue for everyone at this institution. He said it is not out of place to speak about this issue in the absence of the president and Dr. Newbigging.

Woodman said senators should take part in a retreat, held in September, to ensure that everyone participates in a teaching circle to start the conversation on these issues.

Osei asked for patience. He would like to see the apology to be genuine.

Savory-Gordon spoke about previous retreats.

Schantz addressed the fear about grades and said it is a matter for senate and the teaching faculty.

Vaillancourt said she is uncomfortable about the direction of the conversation. She said that some faculty are pulled between AU and SKG. She supported the idea of a retreat.

Briggs said that the retreat should include students who wish to be present, and people in the community, and the administration.

Woodman asked for an update on this matter.

Dupuis promised to provide an update after speaking with the president.

Osei again asked for patience.

Gruner said the Founder's Day Committee is meant to make a space for dialogue, and there will likely be an event in the fall. Gruner congratulated SKG for its accreditation.
