This plan will identify programmes for expansion, continuation, and contraction. The Committee will reasonably ensure that appropriate consultation occurs with all constituents of the University community.

The Speaker responded that the previous academic plan was approved by the Senate in 2010.

Burnett offered a friendly amendment to change the deadline from April to June.

#### **MATH 1911 Finite Mathematics**

The following topics will be studied: introductory algebra and trigonometry; matrices and systems of linear equations; descriptive statistics and elementary probability. Antirequisite: Students registered in degree programmes in Mathematics or Computer Science or B.Sc. or B.Eng. programmes may not receive credit for MATH 1911 E except under such special circumstances as may be approved by the Committee on Admissions, Promotions and Requests. As a prerequisite, this course is equivalent to the Finite Mathematics OAC and may not be taken by students with credit in the Finite Mathematics OAC.(LEC 3, TUT 1) (3 cr) Prerequisite: Grade 12 Mathematics or permission of the Department.

#### <u>To:</u>

# MATH 1911 Precalculus

The following topics will be studied: number sets, basic algebra, functions and the algebra of functions, introductory matrices with applications, Cartesian geometry, polynomial, rational, exponential and logarithmic functions, descriptive statistics and elementary probability. This course is equivalent to Advanced Functions MHF4U and contains topics from Mathematics of Data Management MDM4U. This course is intended for students who do not have credit for Advanced Functions MHF4U. It is highly recommended to social science students as preparation for Statistics 2126.

Pre-requisites and Anti-requisites (cross listings): MATH 1101 or Grade 11 Mathematics (MCR3U or MCF3M); Anti-requisites: Students wishing to concentrate in Mathematics and/or Science will not be allowed a Mathematics credit for MATH 1911. Students may not enroll in MATH 1911 if they have already received credit for MATH 1056, MATH 1057, or MATH 1036. (LEC 3, TUT 1) (3 cr)

## From:

#### MATH 1912, Elementary Calculus

The differentiation and integration of simple functions will be studied. Students registered in degree programs in Mathematics or Computer Science or B.Sc. or B.Eng.programs may not receive credit for MATH 1912 except under such special circumstances as may be approved by the Committee on Admissions, Promotions and Requests. As a prerequisite, this course is equivalent to the Calculus OAC and may not be taken by students with credit in the Calculus OAC. Prerequisite: Grade 12 Mathematics or permission of the department. Students may not retain credit if OAC or U Math has been completed. (LEC 3, TUT 1) (3 cr)

## <u>To</u>:

#### MATH 1912, Elementary Calculus

New Calendar Description (use complete sentences): The topics to be studied in this course include the following: sequences, series and sigma notation; trigonometry; limit theory, differentiation of algebraic, logarithmic, exponential and trigonometric functions using rules of differentiation and applications of the derivative including optimization. Anti-derivatives of simple polynomial functions will be used to introduce integration but no techniques of integration or applications of integrals will be included.

This course material is meant as a replacement for the calculus section of MCV4U (Calculus and Vectors) and supportive topics from grade 11 and 10. It may not be taken by students who have not taken MATH1911 or MHF4U (Advanced Functions). This is an excellent course for students requiring some basic knowledge of Calculus for Business or non-physics Science courses. Pre-requisites and Anti-requisites (cross listings): MATH1911 or MHF4U. Anti-requisite: Students wishing to concentrate in Mathematics and/or Science will not be allowed Mathematics credit for MATH1912. Students may not enroll in MATH 1911 if they have already received credit for MATH 1056, MATH 1057, or MATH 1036. (LEC 3, TUT 1) (3cr)

James stated that courses had been updated to match the changing curriculum in high schools.

These two conditions for the continued offering of the foundation and transition courses will ensure appropriate course placement and maintain the appropriate conditions of course progression.

A number of concerns were raised over wording of the motion which led to discussion regarding the Canadian Adult Achievement Test (CAAT).

Perlini stated that we are planning for 30-40 new international students and that we do need to offer foundations courses. The CAAT determines what level a student is at literacy and numeracy skills.

Denomme brought forth the issue of students taking condensed courses and not being eligible for OSAP.

Broad stated concerns regarding this matter and made reference to five students who recently withdrew from studies in Timmins because they could not receive funding because they were enrolled in compressed courses and therefore, were denied OSAP. She added that she was reluctant to put students in a similar situation.

Vaillancourt asked whether the intent of the accelerated program is to target international students .

Schantz stated that it is a fully functional program paid for by the Ministry and OSAP. Some of the students will be international, therefore, not impacted by OSAP. Every university offers condensed courses not just Algoma University.
