HIST 2796 Path of the Warrior: History, Philosophy, Ethics, and Practice in Eastern Martial Arts

This course will survey the beginning and historical evolution of eastern martial arts, with special emphasis on Japanese martial arts. The course will review the dominant philosophical undercurrent that surrounds eastern martial arts, Zen Buddhism, and examine how elements of this philosophy have found their place in the development of Budo, the Martial Way. Through the study of selected texts, students will be exposed to the code of the Samurai (Bushido), the mighty feudal warrior class, whose moral code is still at the core of Japanese social, political and corporate structure. The course will finally examine the life, contribution to the development and introduction of Shotokan karate and the lasting spiritual legacy of one of the greatest martial arts masters of all time, Gichin Funakoshi. Through practical training sessions, students will be introduced to the philosophy, moral code, ethics and practice of Japanese martial arts by hands-on practice of one of the most widespread martial arts on Earth, Shotokan Karate. Students may not retain credit for HIST 2796 and PHIL 2796. (lec/exp 3) 3 cr
