JURI 2996 Legal Research Methods

This course provides students with a foundation for conducting legal research. Students will locate and analyze primary and secondary legal materials. At the end of the course, students will have experience locating, tracing, and effectively utilizing legislation, cases, government documents, treaties and land claims information, as well as relevant literature for their own research. (LEC 3) 3 cr

To:

JURI 2996 Legal Research Methods

This course introduces students to strategies for effectively conducting research using legal materials such as legislation, case law, and legislative records. (SEM 3) 3 cr

Rationale:

This is part of a larger revision of the JURI programme. A new methods course - serving both JURI and POLI - is being created, with an emphasis on the "social science" research methods used in these disciplines. This course is being revised to focus only on the more technical legal research skills. Navigating legal databases to find case law and legislation requires specialised skills that cannot reasonably be taught in the same three-credit course as the other research methods needed in an interdisciplinary programme like JURI. Some JURI students will need these specialised skills for upper-level research courses.

> Moved [Meades/R. Cameron]: that the Algoma University Senate approve the following new course as submitted by the Department of Law and Politics:

JURI/POLI 2856 Research Methods in Law and Politics

The course introduces students to research in Law and Political Science. It explores the research process and the elements of research design. It focuses on quantitative, qualitative, and hermeneutic approaches; and it emphasizes on the methods of data collection and data interpretation used in Law and Political Science. The course also includes a brief overview of the epistemological status of Law and Political Science.

Prerequisite: POLI 1006/1007 or JURI 1106/1107 or permission of the instructor. Students may not retain credit for more than one of JURI 2856, POLI 2856, POLI3127. (LEC 3) 3 cr

Rationale:

The department's two existing methods courses, POLI 3127 and JURI 2996, have been cross-listed for the last two years. Since cross listing has worked well, we would like to formalize this arrangement, instead of cross listing two courses with different levels and course descriptions. The two areas of research methods are cognate enough to warrant a crosslist, and doing so makes effective use of our department's teaching resources.

Currently, POLI 3127 is a core requirement for the BA3.POLI and BA4.POLI programs, and the

new POLI 2856 course would replace this as the core methods requirement for POLI degrees.

The new JURI 2856 course that will be cross listed with POLI 2856, will eventually be made a core requirement of the JURI programs. We are not yet asking for this modification, however.

Currently, JURI 2996 is NOT a core requirement for JURI programs. We will eventually propose to make the new JURI 2856 methods course a requirement for the JURI program, but this will be part of a later, larger, major modification proposal, coming later this year. At the same time as this new course proposal, we are proposing a Course Revision to JURI 2996, to make it a second JURI methods course, one more specifically geared to case law and legislation. It will not be a core requirement. JURI will have two methods courses (JURI 2996 and JURI 2856), POLI will have only one, POLI 2856, cross listed with the new JURI 2856..

POLI 2856 Research Methods in Law and Politics [core]

Rationale:

We have already been offering POLI 3127 and JURI 2996 as cross listed, so we want to formalize this arrangement, and we think a move from POLI 3127 to POLI 2856 exposes POLI students to the vital methods training sooner, better preparing them for upper year research. Cross Listing makes sense given the cognate disciplines, and this takes advantage of our full time faculty member's expertise, which can cross both areas of research. It uses HR resources efficiently, as well.

Introducing a second JURI methods course allows a general JURI social science research course (cross listed with POLI) to become a core requirement of the JURI program, and train students in fundamentals of social science, and legal research. Having JURI 2996 become a revised specialized research methods course in case law and legislation, an elective within the JURI program, deepens interested students' study of the law.

The Registrar informed the Senate that the PMGT courses to support certificate students were not part of the course roster for 2022-23. Additionally, the Geography roster is missing since the Science Faculty has yet to approve the department's roster.

A question was raised regarding representation from the Shingwauk Anishinaabe Students' Association [SASA]. A motion was made to defer the original motion so that the committee could consider the request at the next meeting [January 2022].

21.12.04.03 Institutional Quality Assurance Process [revised IQAP]

Moved [Rogers/Spurway]: that the Algoma University Senate approve the revisions made to the Algoma University Institutional Quality Assurance Process (IQAP) as recommended by the Quality Assurance Committee of the Senate and approved by the Academic Planning and Priorities Committee.

Rationale:

As part of its ongoing commitment to offering graduate and undergraduate programs of high quality, Algoma University has adopted the Quality Assurance Framework of the Ontario Universities Council on Quality Assurance. In accordance with this Framework and Algoma's history of commitment to quality education, the University undertakes to establish, maintain and enhance the academic quality of its programs, in keeping with its academic mission and its institutional degree expectations.

The processes of the IQAP have been effective in fostering innovation while maintaining academic excellence. Our quality assurance processes reflect our commitment to excellence in undergraduate and graduate education.

The Dean added some context to the proposed revisions to the IQAP including that some of the changes are directly from the Quality Assurance Framework, recommendations from the official audit of the Quality Council and addition of graduate level learning outcomes.

Discussion arose of whether EDI [IEDI] perspectives were considered and what consultation was made to ensure these considerations. It was made clear that the IQAP is guided by the special mission and EDI perspectives. As well, the Indigenous Learning outcomes recently *Algoma University, Senate minutes, December 3, 2021*

approved at the Senate were embedded in the document to assist faculty who are interested in the development of indigenous content in their courses/programs.
