**22.01.03.01 Faculty of Cross-Cultural Studies - proposal**

- ***Moved [Woodman/Steeves]: that a Faculty of Cross-Cultural Studies [FCCS] be established by the self-selecting of departments/programs of Algoma University.***

The motion to create a Faculty of Cross-Cultural Studies [FCCS] was discussed at length. The Senate was informed that the motion on the floor does not compete with other motions in the Senate package. Members brought forward their concerns with the concept, however, faculty who were working on the proposal welcomed the motion and the extensive work that was involved.

The establishment of the FCCS is a beginning space to emphasize the importance of the special mission and to support anishinaabe communities and culture. The proposal addresses decolonization and indigenizing postsecondary education not to challenge mandates from our partners. The proposed faculty would address some of our initiatives regarding the calls to action. Some indicated that there was not enough consultation with our partners to move forward, therefore, there were reservations regarding the proposal.

For the motion to be approved, the Senate will require a two-thirds majority vote.

**22.01.03.02 Academic Restructuring**

- ***Moved [Marasco/Burnett]: that the Senate Executive committee recommends to the Algoma University Senate that the Faculty of Social Sciences and the Faculty of Humanities be replaced by the Faculty of Business and the Faculty of Humanities & Social Sciences, effective July 1, 2022, as per the 'Report to Senate***

***on an Academic Reorganization for Algoma University' submitted by the working group.***

Rationale:

In an effort to engage in a bottom-up process to determine whether the current single-Dean structure or a new multi-Dean structure would best serve faculty members, the faculty members who sit on Senate Executive (elected Faculty Chairs and Speaker/Deputy Speaker) were asked to work together to find our way forward. As a working group we conducted, over eight months, various polls, a town hall, many conversations (e.g., with AU colleagues at Faculty meetings), and meetings with four Deans from other universities. We also undertook relevant research (e.g., on the workload requirements for the Deans, the current Faculty structure, the number of FTEs, and a way to create equitable governance/committee structures). The conclusion that this working group reached was that there is both a need and a desire for Faculty-specific Deans. (Please refer to the Report for data/more information—and for more details with respect to our rationale).

Therefore, in order to direct the Decanal Search Committee to begin its work, we are recommending the creation of a Faculty of Business, a Faculty of Humanities and Social Sciences, and a Faculty of Science, each with its own Dean. Each of these Faculties would have approximately equal FTE numbers (please refer to the Report), resulting in similar workloads amongst the Deans. While faculty numbers are not equal across the proposed Faculties (please refer to the Report), given the extensive number of part-time faculty in the School of Business and Economics (which would become the Faculty of Business), we believe that the workload associated with this Faculty justifies the need for an independent Dean.

We further recommend oversight at the Timmins and Brampton campuses, as both are growing, Brampton especially quickly, and both are in need of academic oversight. Therefore, Associate Deans should be situated on site, and assigned to the specific workloads at their respective locations.

We did not recommend the creation of a Faculty of Cross-Cultural Studies (FCCS) because a Notice of Motion to create a FCCS went to the Senate before we had finalized our Report and Recommendations.

The Senate was engaged in discussion regarding the benefits of an academic restructure supporting the growth of the institution and creating efficiencies to make informed decisions. There was also dialogue with respect to an activity-based budget model and how that will be incorporated based on the academic changes. There were additional questions regarding what this meant for representation of Senate and Senate standing committees – the question was related to collegial governance.. Another question was raised if the current motion was to fail, what would happen with the second motion – Senate was informed that the second motion would be deferred.

The Speaker reminded the Senate that a two-thirds majority vote is necessary to approve the motion on the floor regarding academic restructuring..

- ***Moved [Marasco/Rogers]: that the Senate Executive committee recommends to the Algoma University Senate that the position of Academic Dean at Algoma University be replaced by a Dean of Business, Dean of Humanities & Social Sciences, and Dean of Sciences, effective July 1, 2022, as per the 'Report to Senate on an Academic Reorganization for Algoma University' submitted by the working group.***

The Speaker reminded the Senate that the motion on the floor requires a majority vote [50% + one]. The reason being that we cannot assume at this time the role[s] the three Deans will play in the Senate. Also, some Senators questioned how the committees will be constituted with the new Dean structure – will there be balance to guarantee collegial governance?

Motion carried. [24/30 yes votes, 6/30 no votes]

#### COSC 4896 Computer Science Co-Op Work Term III

Any IT, computer science, research, software development, or project management-related work will be used in the contents of the course. During the work term, students need to submit a mid-term progress report. After successful completion of a co-op term, students will have to submit two papers: a letter of reference from the supervisor about his successful completion of the co-op term and a report that describes the detailed job responsibility of the student. A full-time faculty from the school will review and evaluate them and recommend grades (Pass/failure). Pre-requisites: COSC3896 (Computer Science Co-Op Work Term II) or the permission of the school. ***\*\*In all cases, students must respect the prerequisite course requirements, if any, for all upper year courses.***

Rationale:

For the following reasons, the revisions have been recommended:

1. With the number of students enrolled in the Project Management certificate program [~ 700 students], the streams have been difficult to manage including academic advising and course rostering;
2. Many students do not understand the streams and require assistance. For the most part students gravitate to Business/Economics and Information Technology;
3. Advisors have had difficulty advising students as to their fifth course for each term as part of the stream; in some cases, after the prescribed registration, some students have failed to follow-up with their fifth course and now find themselves in requesting overloads for a subsequent term;
4. Having a 'Project Management Approved Course List' will ease the 'resourcing' strain on academic departments and schools and will allow academic units for a streamlined roster process;
5. Replacing the streams will allow for students to maximum course selection according to interest, timetabling, etc.;
6. This will allow other academic units to contribute to the Approved Course list.

The standard operating procedure of course mode of delivery changes to existing courses recognizes the importance of addressing pedagogical changes as well as student access to instruction. The intent is to assist academic units to facilitate modification to mode of delivery with the least amount of barriers and support continuous improvement, quality delivery and responding to meet the needs of our students.

Discussions have been underway for some time for the delivery of CESD degree programming in Brampton, and faculty resourcing (3 year CLTA) has been granted to support this delivery. CESD has various College transfer articulation agreements with colleges in and around the GTA, many of which have expressed interest in the delivery of these degrees at the Brampton location. Further, interest in this type of undergraduate degree programming

(environmental sustainability, community development, planning and related areas central to the CESD program) has been expressed by the city of Brampton.

The modification is related to CESD expanding programming to Brampton after 3+ years of discussion with APPCOM. There will be no impacts on learning outcomes as it is the same two degrees (CESD 3&4) proposed for delivery at another campus location. This is possible as we will continue to meet our PLO's while having a comparative sample [students from the GTA] which is no different from when we have international students in the classroom or when we engage in COIL projects - it just adds more diverse learning to the mix but does not change our learning outcomes.

Students from the GTA area will be able to stay in their home communities and access this program from Brampton rather than moving to SSM as has been the requirement in the past. This expansion required faculty resourcing and this has been granted so the impacts on the program otherwise should be minimal (some oversight by the Dept. Chair, rostering, etc..

CESD degrees all commit to and demonstrate work on the special mission in terms of Indigenization of curriculum, and learning labs in the Intro classes led by Indigenous scholars. These degrees also fit the Academic plan priorities as they include experiential learning in CESD 3017 (150 hours) and CESD 4016 & 4017 (300 total hours). CESD courses also have global/local concepts and content, have been a part of the COIL pilots and mobility exchange (COIL mobility exchange to Spain planned in winter 2022) and include Special topics and undergraduate research opportunities with faculty that work on global issues, demonstrating CESD's commitment to both Internationalization and inter/cross-cultural learning.

CESD's distinctiveness has been in its substantial placements in the third and fourth years, its connection of global to local issues, its commitment to Indigenization of curriculum and inter/cross-cultural learning -all of which will continue. As we do not have an advisory committee for Brampton yet, this is a future project we would develop to guide programming once there (which is a distinctiveness of CESD programming) just as the SSM community advisory is for SSM and the Timmins community advisory is for Timmins.
