#### **FACULTY OF HUMANITIES AND SOCIAL SCIENCE**

Moved [Khan/Nyaga]: that the Algoma University Senate approve the following revised courses as submitted by the School of Social Work:

SWRK3206 <u>Critical Social Work Practice</u>: Anishinaabe, Structural and Feminist Perspectives
This course enables students to critically analyze social realities and social work knowledge,
theories and approaches, with an aim of developing a critical, reflexive, and anti-oppressive
approach to social work practice. Theories of power, oppression, and resistance and processes
of social change will be examined, with a focus on integrating structural, Anishinaabe and
feminist perspectives. These critical approaches will be contrasted with dominant approaches
to social work practice. The aim of this course is to equip students to address social injustice
and engage in social change processes through social work practice in Indigenous, northern,
rural, and remote contexts. Prerequisite: This course is restricted to students admitted into the
professional years or permission from the instructor. (SEM/WIL 3) (3 cr)

SWRK3206 <u>Critical Social Work Practice</u>: <u>Anishinaabe</u>, <u>Structural and Feminist Perspectives</u>
This course enables students to critically analyze social realities and social work knowledge, theories and approaches, with an aim of developing a critical, reflexive, and anti-oppressive approach to social work practice. Theories of power, oppression, and resistance and processes of social change will be examined, with a focus on integrating structural, Anishinaabe and feminist perspectives. These critical approaches will be contrasted with dominant approaches to social work practice. The aim of this course is to equip students to address social injustice and engage in social change processes through social work practice in Indigenous, northern, rural, and remote contexts. *Prerequisites: SWRK 2106/2107 with a minimum grade of 70% or permission of the School of Social Work (SEM/WIL 3) (3 cr)* 

## Rationale:

SWRK 3206 is a third year course for social work students. The original prerequisite for this course was the admission to the Professional Years of the BSW program. The School of Social

### SWRK3456 Social Work Research and Program Evaluation

This course recognizes the ethical and professional responsibility of social workers to evaluate the effectiveness of their practice and the programs in which it takes place, to contribute to social work's knowledge base and to use research literature to guide decision-making in anti-oppressive practice and program development. Students will learn to critically evaluate the findings of social work research and to develop their competence in various approaches to qualitative and quantitative research. The course will consider the particular challenges of conducting research and program development in Northern, remote/rural, Anishinaabe and Franco-Ontarian communities. Prerequisites: SWRK 2106/2107. This course is restricted to students admitted into the professional years. (SEM/WIL 3) (3 cr)

### SWRK3456 Social Work Research and Program Evaluation

This course recognizes the ethical and professional responsibility of social workers to evaluate the effectiveness of their practice and the programs in which it takes place, to contribute to social work's knowledge base and to use research literature to guide decision-making in anti-oppressive practice and program development. Students will learn to critically evaluate the findings of social work research and to develop their competence in various approaches to qualitative and quantitative research. The course will consider the particular challenges of conducting research and program development in Northern, remote/rural, Anishinaabe and Franco-Ontarian communities. *Prerequisites: SWRK 2106/2107/2127 with a minimum grade of 70% or permission of the School of Social Work (SEM/WIL 3) (3 cr)*

SWRK 3456 is a third year course for social work students. The original prerequisite for this course was the admission to the Professional Years of the BSW program. The School of Social Work removed the Professional Years admission process and this has been approved by the Senate. As a result, it is mandatory that students have the required prerequisites from second year to take this course (see details above).

# SWRK3596 Social Work Philosophy and Ethics

This course will examine social work ethics in the context of Social Work (particularly structural Algoma University, Senate minutes, December 2, 2022 and anti-oppressive Social Work) and Anishinaabe world views and values. Students will become familiar with the CASSWE Code of Ethics as well as the IFSW Code of Ethics. They will learn to critically think about ethical issues in carrying out the tasks of Social Work practice, policy and research in the context of Northern and remote/rural settings. Models of ethical decision-making processes, critical thinking and problem-solving are explored and applied to micro, mezzo and macro levels of practice. Prerequisites: SWRK 2356. This course is restricted to students admitted into the professional years. (SEM/EXP 3) (3 cr)

## SWRK3596 Social Work Philosophy and Ethics

This course will examine social work ethics in the context of Social Work (particularly structural and anti-oppressive Social Work) and Anishinaabe world views and values. Students will become familiar with the CASSWE Code of Ethics as well as the IFSW Code of Ethics. # POLI4506 Resistance and Revolution

This course explores the meanings, causes, strategies, and effects of political revolution and resistance to regimes of power. We will study the lasting influence of Socratic critical thinking and Aristotle's notion of political action (praxis), civil disobedience, violent vs. non-violent forms of resistance, Hegel's master-slave dialectic, decolonizing practice, psychological and spiritual dimensions of political struggle, indigenous resistance to settler state and capitalist hegemony, Marx's account of revolution and teleological history, Arendt's account of modern republican

revolutions, and contemporary cases of resistance. Prerequisite: Restricted to students in an honours degree program offered by the Department of Law and Politics or permission of the department. (SEM 3) (3 cr)

#### Rationale:

This course was an interesting addition to the POLI course offerings two years ago, as a topics course in the spring session. POLI wants to offer it again this spring, and again every 3 springs, so would like to change it from a topics course to a permanent one. Resistance and revolution are core concepts within the study of politics.
