Highlights of the Competition-High School

- Experience a most historical heritage buildings in Ontario the Peel County Courthouse opened in 1867
- Prepare and discuss a series of 3 Mini Case Debate Questions with Progressive Complexity
- □ Prepare the debate arguments from both "For" and "Against" Perspectives

Teams:

- 8 teams of 4 to 5 students each
- A blend of high school and first-year university students
- Two teams paired for each round to debate

Detailed Schedule:

- Preparation time: 30 minutes to prepare and discuss each debate argument
- Presentation time: 10 minutes each team including debating on challenge question

Note: <u>All team members are encouraged to participate in the debate</u>; <u>No powerpoint</u> <u>slides are required</u>; <u>Research tools like Google for fact-checking are allowed</u>; <u>Handwritten slides are allowed to use during debate presentation</u>.

Tournament Style:

- Preliminary: A round-robin model where each team faces every other team once. 90mins
- Semi-Finals: The top 4 teams from the round-robin stage. 40 mins
- Finals: The two winning teams from the semi-finals. 20 mins

Mini Cases for Debate:

- Mini Case 1: Factors of Production and Entrepreneurship
 - **Objective:** Understand the fundamentals of business models and entrepreneurship.
 - **Focus Areas:** Key business planning elements, identification of resources, entrepreneurial mindset.
- Mini Case 2: Ethics and Corporate Social Responsibility (CSR)
 - **Objective:** Examine the role of ethics and CSR in business decision-making.
 - **Focus Areas:** Ethical considerations in business, CSR alignment with government policy, and corporate ethics.
- Mini Case 3: Organizational Behavior and Culture
 - **Objective:** Analyze organizational behavior, talent management, and stakeholder relationships.
 - **Focus Areas:** Corporate culture, stakeholder management, talent retention strategies.

Key Analytical Tools recommended

- **SWOT Analysis** (Strengths, Weaknesses, Opportunities, and Threats)
- **PESTLE Analysis** (Political, Economic, Social, Technological, Legal, and Environmental)

Evaluation and Prizes

- Team Award : Gold / Silver / Bronze Award
- Individual Award: Best Leader Award / Top Debater Award

Judging Criteria:

- Depth of case analysis using analytic tools like SWOT and PESTLE
- Clarity and effectiveness of debate presentations
- Ability to argue either "For" or "Against" perspectives in line with the case study theme
- Presentation and debate skills
- Equitique and dress code
