

# 26W FAQ for Student Accounts

## CAN I REGISTER 26W WITH OUTSTANDING FEES FROM A PRIOR SEMESTER?

No, your account will be placed on restriction until the outstanding balance is paid in full and you therefore will be unable to register. Please clear your balance to avoid any disruption to your registration process.

## WHAT IS THE PAYMENT DEADLINE FOR 26W FEES? CAN I PAY MY FEES AFTER THIS DEADLINE?

Tuition fees for the 26W term must be paid **no later than the first day of classes, January 7, 2026** (excluding OSAP and Sponsored students). Students who do not pay their full balance by this date will be charged **5% annual interest, applied monthly**, and will automatically be placed on the **26W Payment Plan** outlined below.

You *can* pay after the January 7 deadline; however, interest will apply and your account will follow the payment plan schedule.

### 26W Payment Plan (One-Time Trial):

Students who have not paid in full by January 7, 2026 will automatically follow this four-installment plan:

- **25% due January 20, 2026**
- **25% due February 20, 2026**
- **25% due March 20, 2026**
- **25% due April 20, 2026**

### Important Notes:

- No sign-up is required; the plan applies automatically if your balance is not paid in full by January 7, 2026.
- Students who pay in full by January 7, 2026 will avoid interest charges and will not be on the payment plan.
- Missing any required payment or deadline may result in **cancellation of registration**, as per [Section 5.1.15 of the Academic Calendar](#).
- All outstanding balances continue to accrue interest at an annual rate of 5%, applied monthly.
- Students receiving OSAP funding or sponsorship are **not required to meet the January 20, 2026 installment deadline**. Their existing later payment deadline of January 30, 2026 will continue to apply. Any balance remaining after this deadline is subject to interest charges. Funded students are responsible to pay the balance owing after funding is applied.



## **I PAID MY FEES FOR THE UPCOMING TERM, BUT MY ACCOUNT BALANCE IS INDICATING THAT I HAVE OUTSTANDING FEES. WHAT SHOULD I DO?**

### New Students:

## **HOW CAN I OBTAIN MY FEE/PAYMENT RECEIPT AFTER MAKING A PAYMENT?**

If you made a payment through Flywire or PayMyTuition you will be emailed the payment confirmation. Receipts provided by Flywire or PayMyTuition are suitable for all immigration purposes and as such we do not issue additional receipts. You are also able to download your account statement via the [student portal](#).

If you paid via online banking, please log into your [student portal](#) to download your account statement.

## **I RECEIVED A FINANCIAL BURSARY FOR MY PROGRAM. WHAT IS THE RELEASE SCHEDULE OF THE BURSARY INSTALLMENTS?**

Entrance bursaries (as noted on your LOA) are awarded and applied to your account after the final day to make registration changes for the term, provided you remain eligible for the award.

## **WHAT ARE THE ACCURATE FEES FOR MY UPCOMING SEMESTER?**

Your accurate fees will populate once you register for your courses for the upcoming semester. Your fees will change if you make registration changes. Ancillary fees are non-refundable after the first day of class.

financial penalty below.

## **WHAT IS THE LAST DAY TO WITHDRAW WITHOUT A FINANCIAL PENALTY FROM 26W FOR RETURNING STUDENTS?**

- Ancillary fees are non-refundable after the first day of classes.
- The **last day to receive a tuition refund (minus the non-refundable deposit)** is **January 21, 2026** (14 days after the first day of classes).
- A **non-refundable tuition deposit** applies to all withdrawals after registration:
  - \$200 for domestic students
  - \$1,000 for returning international students
